- Every alliliated school shall sponsor regularly its bonafide and eligible students in Boards Class XI and Class XII examinations from the year mentioned while granting affiliation/up-gradation regularly without break or inform with reasons thereof in writing well in the allow tipe non-sponsoring of the candidates.
